Arts Council Response Fund: Organisations



This is our fund for creative organisations directly affected by the Covid-19 coronavirus emergency



We want to help organisations to **keep going**. Our funding might help to support your business



We also want to support **activities** delivered over the next **6 months**. This could be **development activity**...



...or it could be a **public facing activity**, like a digital project



We can make grants of up to **£35,000**, to be used within **6 months**

Can I apply?

You can apply if:



Your organisation is **not** a National Portfolio Organisation, Music Education Hub or Creative People and Places



Your main work focuses on one of these areas:

- **Combined arts**
- **Dance**
- **Libraries**
- **Literature**
- **Museums**
- **Music**
- **Theatre**
- **Visual arts**



Your work has been funded by public money over the last three years. This might be from the Arts Council, other Lottery funders, a university or local government, for example

18+

Your organisation has a responsible person who is **18 or over**



You must be based in **England**



You must apply as an **organisation**, not as an individual. Make sure you have a **UK bank account** in the name you're applying in

Plan ahead



If you have enough money from another source, please don't apply. Let us know if you are applying to any other funds or sources of support.



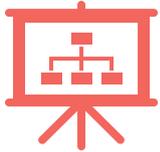
This fund will be very popular. We won't be able to fund everyone who applies



Think about what you will do if we can't fund your application

✓ What can we use the money for?

Activities over the next **6 months** that will help you **keep going**. These might include:



Changes to your **business model**



Operational costs, like rent or staff costs



IT equipment or **software**, to help your staff do their job from home, or to deliver digital work



Development activities to help your organisation get ready to restart



Public facing activities, like a digital project

✘ What can't we apply for?



Projects we would normally fund through Project Grants, like a tour or activities taking place beyond the next 6 months



Costs, losses or debts that have **not** happened because of the Covid-19 emergency



Individuals cannot apply. We have a separate [Response Fund for Individuals](#)

Applying



All applications must be made online. Use our [online application portal](#) to apply



There will be **two rounds** in 2020.



You can only apply to one of these rounds. **Don't rush an application if you think you need more time**

Portal closes for applications	Thursday 16 April 2020 12pm midday	Thursday 30 April 2020 12pm midday

We aim to start notifying applicants of the outcome of their applications to **Round one** by the **end of April**.

What we will ask you



How much money do you need?

Up to £35,000



Show us the losses your organisation has faced because of the Covid-19 emergency



Keep any emails, contracts or bank statements that prove you have lost money. We might contact you later to ask for evidence



Tell us about your organisation's work in the publicly funded arts and culture sector



Tell us about any projects or work you have done in the past that got money from bodies like the Arts Council, other Lottery funders, universities, local

authorities, public sector bodies or trusts and foundations

We want to hear:

- What you've worked on
- Who you've worked with
- Who paid for the work



Tell us what difference a grant would make to your organisation.

We'll ask to see the following things:



- A simple budget and cashflow
- Your last year's turnover
- Your reserves position

We'll ask you how you might use the funding over the next 6 months

You don't need to have match funding, but we'd like you to tell us if you are expecting to receive emergency funding from any other sources



Tell us if you will be delivering any activities that go towards our new strategy, *Let's Create*

Use the three outcomes in [our new strategy](#) to explain how your work will deliver against them in the next 6 months



Tell us how the funding will help you contribute to *Let's Create* in the future

Use the three outcomes in [our new strategy](#) to explain how your work will deliver against them beyond the next 6 months

How do we make decisions?

To decide which applications to fund, we will use:



The **answers** to the questions we ask in the **application form**



The information on your applicant profile in **Grantium**



Our **knowledge** as the development agency for creativity and culture

To help us make decisions we also think about the following things:



Whether the organisation is **disabled-led**. We want our funding to go to the organisations that are most vulnerable



Whether the organisation is based in an area of **low cultural engagement**. We want to make sure that our funding benefits the people who need it most



Whether our funding will be used to cover the artforms and disciplines we support



Whether the organisation can help deliver *Let's Create* once the Covid-19 emergency eases

What happens next?



Your application will be considered alongside other applications at a decision meeting



We'll start to let people know the outcome by the end of April for Round 1. Later for Round 2.



You'll get an email asking you to log in to find out your result



If you're successful, you'll need to provide your bank details and ask for your first payment from us
